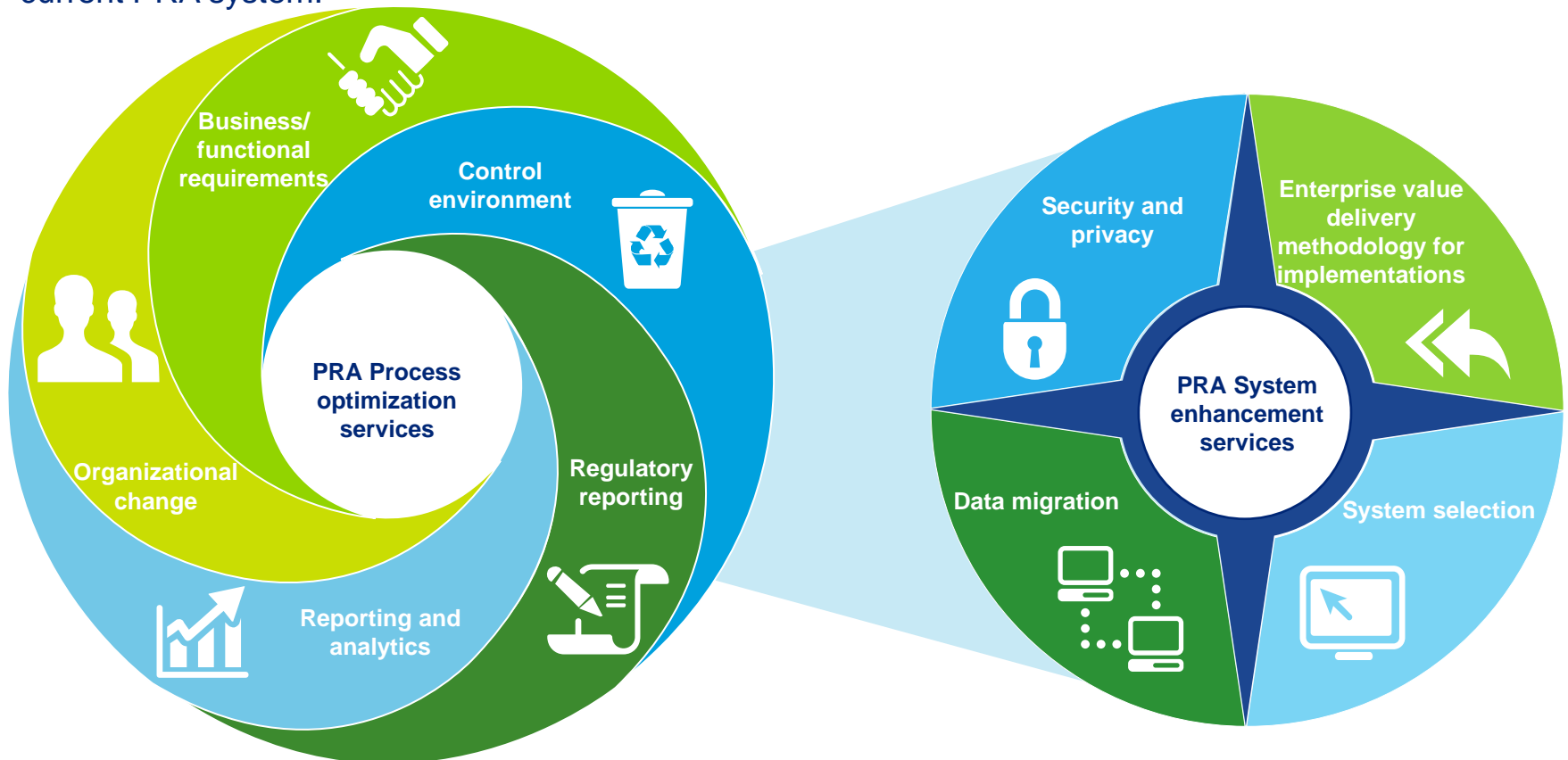

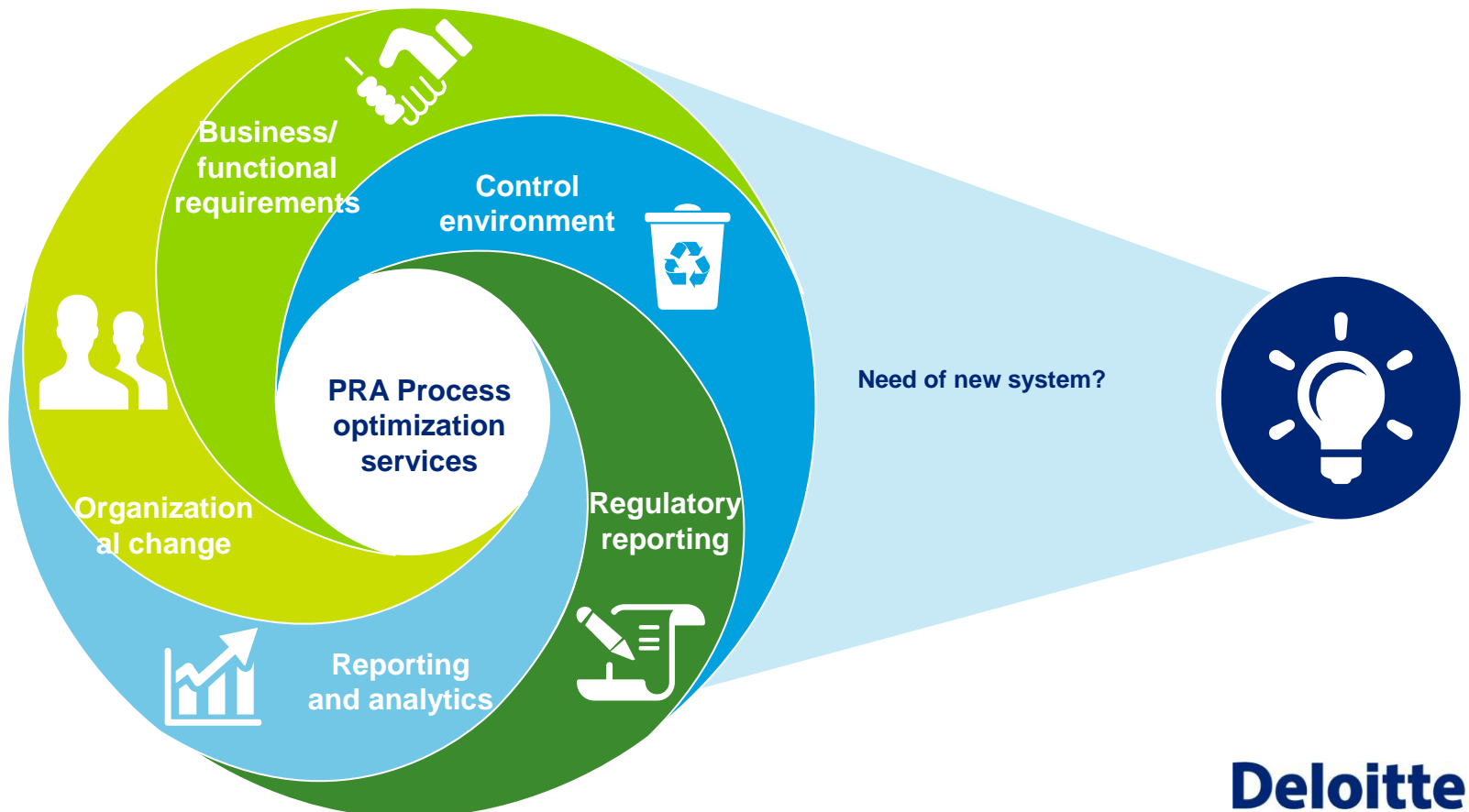
Our View

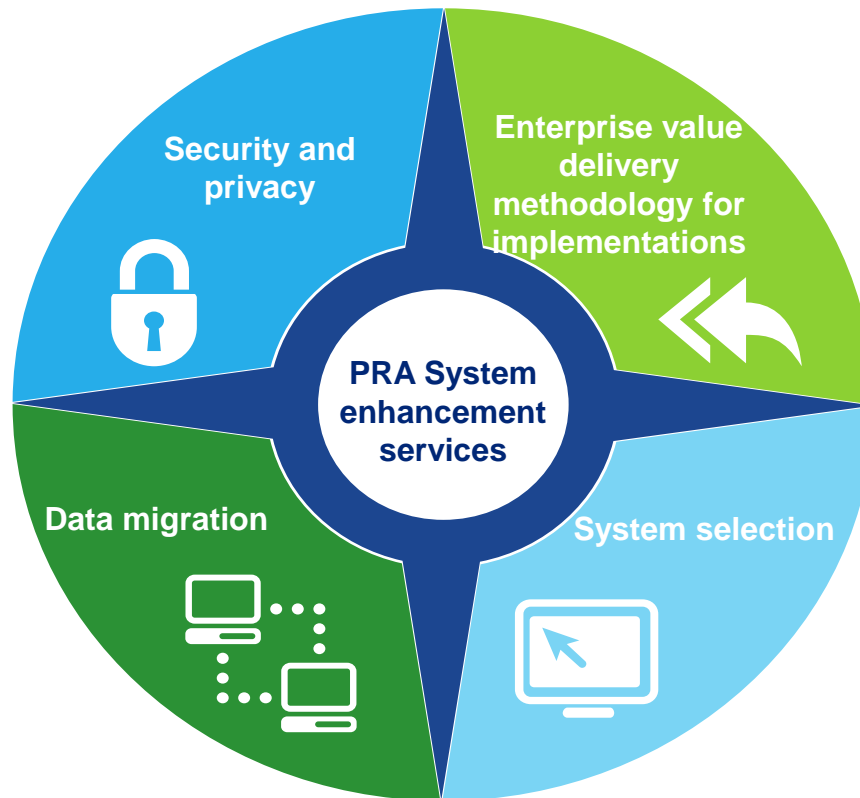
